### **Term and Conditions:-**

1. Selection of the Operating Agency for operation, maintenance and management of Cold Storage will be through a transparent, competitive two-bid process consisting of Technical and Financial Bid. Pre-Qualification Criteria.
2. The Technical Bid would be evaluated on the basis of the following eligibility criteria and valid documents furnished by the bidder. The financial proposal of only pre-qualified bidders would be opened.
3. The bidders must be a Functional Co-operative / FPO / Startup under make in India / Industrial Entrepreneur / SHG / Companies incorporated in India or registered partnerships in India or proprietary concerns / Chamber of Farmers.
4. **Experience :-**
  - (a) Bidder should have at least 03 (three) years of experience in service business, preferably in business or in supply chain or logistics business Food Processing handling of vegetables and fruits. (Work orders, MOUs etc. to be enclosed)
  - (b) Turnover – Should have annual financial turnover or Rs. 100.00 Lakhs (One Hundred Lakh only) from business / activities (as listed under [4.(a) above] during any two financial years in the 3-year period from 2020-21 to 2022-23. (Certificate from Chartered Accountants to be to be enclosed).
  - (c) Net Worth – Should have a net worth of not less than Rs. 100.00 lakhs (One Hundred Lakh only.) (Certificate from Chartered Accountants to be enclosed).
  - (d) Should have GST Registration.
5. The Financially qualified bidders, who satisfy the eligibility criteria as above will be evaluated on the basis of the price bid. The price bid will have only one unconditional offer, i.e. the quarterly lease rental payable by the bidder. All other financial conditions shall be fixed and no deviation shall be allowed. They are as follows :-
  - ‘Minimum or Reserve Annual Lease Rent’ per Cold Storage is Rs. 10,00,000.00 (Ten Lakh only) + Applicable taxes. Bidders are required to quote above minimum or reserve annual lease rent and any quote below this amount will be summarily rejected.
  - Lease rent to be paid Quarterly in advance plus applicable GST or such rates as fixed by Govt. of India/Jharkhand from time to time on or before the 7<sup>th</sup> day of the

respective month. If there is any delay in payment, the Agency shall pay interest @12% per annum from date of bill till date of payment.

- There will be no increase in Lease rent for the first three years, but after that Lease rent will be escalated once every two year @ 12%
- Security Deposit of twelve months lease to be deposited on signing on contract.
- Operation, maintenance and management contract shall be for a period of 5 years, renewable for a further period of 5 years on satisfactory performance.
- GST / any taxes will be applicable with lease rent. If any.

6. The Technical Bid should be submitted with a covering letter as per format and should include all the required details in the prescribed format.

- Documents proving that the bidders is a Functional Co-operative / FPO / Startup under make in India / Industrial Entrepreneur / SHG / Companies incorporated in India or registered partnerships in India or proprietary concerns / Chamber of Farmers.
- Certificate issued by C.A. certifying annual financial turnover during the last five financial years ending 31<sup>st</sup> March 2023.
- Certificate issued by C.A. certifying current net worth dated on publication of this advertisement.
- Profit and Loss Statement and Balance Sheet during last five years ending 31<sup>st</sup> March 2023.
- Business Plan should indicate proposed cold storage capacity utilization, material / stock indentified for cold storage, the investment proposal, i.e. amount of proposed investments and operational plan consisting of projected income and projected expenditure for 5 years.

7. The Financial Bid shall be submitted in the prescribed format.

8. The technical qualification documents will be evaluated to assess if the applicant satisfies the minimum eligibility criteria required to qualify to bid operating, maintaining and managing the Cold Storage. The financial bids of the proposals received would be opened and evaluated of only those bidders who satisfy the above eligibility criteria.

9. The bid will be selected on the basis of the highest annual lease rent bidder.

10. The Successful Bidder shall be issued Work Order initially for those districts where cold storage work has been finished and later for remaining districts where cold storage is in under construction, the work order shall be given as soon as the cold storage work is finished. After issue of the work order and acceptance of the same by the Successful Bidder within 7(seven)

days, the Successful Bidder shall enter into an O & M Contract with the VEGFED within 10 (ten) days, of receipt or work order and carry out his further responsibilities / obligations.

**11. Tender fee & Earnest Money Deposit (EMD) :-**

- (a) Tender fee for each cold storage is Rs. 1,000.00 and EMD for each cold storage amounting Rs. 1,00,000.00 (Rupees One Lakh Only) will be received through online mode only. Bidders can use internet banking facilities for faster processing of Tender fee and EMD. Alternatively, bidders can use NEFT/RTGS challan generated for the tender from <http://Jharkhandtenders.gov.in> portal. In case of non-submission Tender fee & Earnest Money Deposit (EMD), the bid will be summarily rejected, and financial bid will not be opened.
- (b) EMD will be returned to all unsuccessful bidder after finalization of the successful bidder without any interest.
- (c) EMD of the successful bidder will be returned only after successful execution of the work without any interest.

- e. The firm/company should provide/give the correct and true information while submitting the tender. In case of incorrect/false information found at any stage, the tender/bid will be cancelled, and legal action will also be initiated.
- f. The interested Entity is found to canvass, influence or attempt to influence in any manner, the qualification or selection process, including without limitation, by offering tender or other illegal satisfaction.
- g. Notwithstanding anything written above or elsewhere, the tender may disqualify the Interested Entity without assigning or disclosing any reason thereof.
